Responsibilities:

1. Grant Writing and Research:

- o Partner with Division Heads and Executive Team in identifying potential grant opportunities from foundations, corporations, and government agencies.
- o Draft compelling grant proposals, ensuring alignment with IA&A's programs, initiatives and mission.
- o Collaborate with program managers to gather relevant information for grant applications.

2. Donor Cultivation and Stewardship:

- o Using interns and volunteers, maintain donor databases, tracking contributions, interactions, and engagement levels.
- o Develop and organize donor appreciation events, including receptions, gallery tours, and special exhibitions.
- o Along with the finance team, prepare personalized acknowledgment letters to major donors and ensure timely follow-up with donors.
- o Oversee the CEO's fundraising activities, including meetings, correspondence, and appeals.

3. Annual Fund Campaigns:

- o In partnership with external consultants, support the planning and execution of annual fundraising campaigns.
- o In coordination with program teams, develop schedule and strategy for direct mail appeals, online giving, and peer-to-peer fundraising efforts.
- o Monitor progress toward fundraising goals and provide regular updates to the development team.

- o Conduct research on individual and institutional prospects to inform cultivation strategies.
